Overall Report of Anti-Sexual Harassment Committee about Zero tolerance policy :

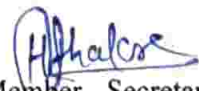

Overall Report of Grievance Committee regarding Anti-ragging, Anti sexual harassment, Student Grievance Redressal, Internal Complaints :

Timely redressal of the grievances through appropriate committees

The grievances are of various nature are immediately forwarded to concern person, department etc. College is taking care of grievances from students, parents, teachers, non-teaching staff and all stakeholders. Mostly grievances are from students

Grievance Redressal Mechanism: After declaration of University results students, if not satisfied, can apply for xerox copy of answer book, re-totaling and revaluation. The revaluation result is declared in time bound manner so that student will not lose the year of study and will not be deprived of admissions to next semester, in this regard college staff is doing grievances redressal. Grievances regarding correction of name in marksheet, wrong posting of internal marks, practical marks, etc. is redressed through college by proper channel in time bound manner.

After internal assessment marks are announced, assignments and class tests papers are given to students and redressal procedures begins immediately. First the students have to approach to subject teachers for the grievance, if problem is not get sorted out then in next step to Approach the HoD, if still problem remains then students can approach Principal. But almost all problems got sorted out at subject teacher's level.



Grievances regarding the issues related to ragging are immediately forwarded to Anti-ragging committee and the grievances regarding eve teasing and sexual harassment in any form immediately forwarded to Anti sexual harassment committee. The meeting of the concerned committee is called on same day or at the most on next working day to sort out the issue and if anyone found guilty then legal action is started immediately.

Grievances regarding the scholarships are handled by concern administrative staff by personally visiting to concern department along with student if needed. College took immediate action in this regard by sending emails and having telephonic talk with concern person from the department to redress the grievance.

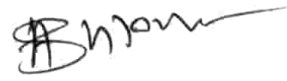

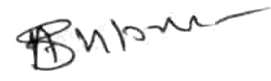

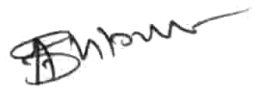
